Environmental Commission: Supervisor Duke & Councilman Ryan said that the Environmental Management Council developed maps for our NRI. The maps cover surface water, slopes, shore lands (riparian), sand & gravel, protected open space, historic districts & sites, ag districts, aquifers, flood plains, bedrock geology, hill shaded elevation, watersheds, wetlands and aerial view. Also, Steve Winkley, New York Rural Water Association presented where he is on developing a Groundwater Protection Plan for the Town of Rochester.

Supervisor Duke gave highlights for the month on Code Enforcement.

Transfer Station - No report.

Councilman Hornbeck attended the Fire Commissioners meeting - their budget was approved by a 4-0 vote.

# Committee Reports/Board Member Reports

Grant Research & Writing Committee - No report

Ethics Board - Councilman Santosky shared that the discussion on defining the amount of time for alleged violations reported to the Ethics Board be discontinued until January when someone else can work on this. He also said that he had spoken to several organizations regarding this issue and was told for the most part that an allotted timeframe was not a part of their laws/policies and that common sense dictated according to each situation.

Planning/Zoning Committee: Supervisor Duke shared the following: Maps have been received from the UC Environmental Management Commission The ECC met with Steve Winkley of the NY Rural Water Association to discuss a study of the groundwater protection in the Town. Sub-committee reports were discussed.

Supervisor Duke announced that the Shawangunk Scenic By Way has been awarded \$65,000 for developing a regional plan for making the region more appealing to residents, tourists and commercial interests.

Rural Character Sub-Committee - Walter Levy shared that the Subcommittee began reconsidering the definition of what rural character means to the Town of Rochester. The definitions of rural character is important because it is at the heart of what the community finds second to taxes as the most important element in its make-up. The subcommittee took up the task to work on the project.

A Clear definition of rural character is needed for flexibility and vision for the Town's future as it is developed for residential, commercial and recreational purposes.

Drafting suggestions for creating an overlay district along Route 209.

Drafting a preliminary version for a code that establishes ground rules for design and architectural review.

Drafting a recommendation for revising the subdivision code that defines major and minor subdivision.

Economic Development Sub-Committee - No meeting, however Town of Rochester bumper stickers were donated at no cost to the Town and they are available to residents while the supply lasts.

Telecommunication Committee - Councilman Gray said there is progress in collecting information related to establishing a Wi-Fi internet capability in the Town.

Cost of Community Services Study Report - Councilman Gray said this report is in final review, when completed will be presentation to the Town residents.
