SCENIC BYWAY CORRIDOR MANAGEMENT PLAN:

Resolution #106-2007

A Motion was made by Councilman Gray, seconded by Councilman Spano that

WHEREAS, the New York State Towns of Crawford, Gardiner, Marbletown, Montgomery, New Paltz, Rochester, Rosendale, Shawangunk and Wawarsing and the villages of Ellenville and New Paltz have been working together since early 2000, first as a steering committee and then as the Shawangunk Mountains Regional Partnership, and;

WHEREAS, this intermunicipal partnership has created the Shawangunk Mountains Scenic Byway Corridor Management Plan, which has led to the official designation of the Shawangunk Mountains Scenic Byway by the State of New York, with the Partnership as the management entity for this important section of the State Scenic Byway System, and;

WHEREAS, the challenges and opportunities facing the region are significant and that by working together from a regional perspective, a common agenda for the conservation and enhanced management of the resources of the region can be advanced in a way that supplements but does not supplant local municipal action, and;

WHEREAS, under Article 5-G Section 119-0 of the General Municipal Law of the State of New York, municipalities have the authority to enter into intermunicipal agreements and jointly perform services regarding subjects each separately has the power to perform, and;

WHEREAS, any financial commitment of any member of the partnership will only be authorized through a resolution adopted by the governing body of the respective municipality.

NOW, THEREFORE, the Town Board duly convened does hereby

RESOLVE that the Supervisor of the Town of Rochester is hereby authorized to execute the intermunicipal agreement establishing the Shawangunk Mountains Regional Partnership.
