- A copy of a certification of insurance naming the Town of Rochester as an additional insured with a public liability limit of not less than \$1 million for damages in which one person is killed or injured per occurrence and not less than \$2 million for damages in which more than one person is killed or injured per occurrence. [Chapter 107-6(J)]
- Monies, amount determined by the Town Board, shall be deposited to the Town Clerk for the Town Code Enforcement Officer's use in hiring an independent sound expert to perform sound measurements. Measurements may be taken up to two times during the racing season at the sole expense of the permit holder.

Applicant agrees to adhere at all times to all provisions of the Code, including Chapter 107, which applicant hereby acknowledges having received and read. Any Person who operates a racetrack in the Town without a permit shall be deemed to have committed an offense and shall be liable for said violation and the penalty therefor. For every violation of any provisions of the Code, the Person(s) so convicted shall be subject to a minimum fine of \$200 and a maximum fine of \$1,000 or imprisonment not to exceed 30 days, or both. Any Person violating the Code shall be subject to a civil penalty, enforceable and collected by the Town, in the amount of \$100 for each such offense for each day that the offense is permitted to continue.
